

ESDO's Brand Audit 2023 Exposes the Major Polluters of SINGLE-USE PLASTIC

In collaboration with Break Free from Plastic, the Environment and Social Development Organization (ESDO) conducted its 6th Brand Audit in Dhaka and Rangpur, two significant divisional cities in Bangladesh.

In Dhaka, the brand audit was carried out by a team consisting of students from Lalmatia Girls High School, Lalmatia Housing Society School, and St. Joseph Higher Secondary School, along with volunteers and ESDO team members. Simultaneously, in Rangpur, students from Rangpur Zilla School and Rangpur Govt. Girls High School has conducted the brand audit.

The combined effort in these two major divisional cities resulted in the collection of approximately 158 kilograms of plastic waste.

They identified the widely used toothpaste, baby wipes, mouthwash, and hand wash through market research. The potential product list for sampling has been finalized by the team. The research team will determine hazardous which compounds. dangerous to both adults and children, are present in these products.



Sampling for EDC-free Asia II Projects



The Asia Pacific regional preparatory meeting for COP-5 of the Minamata Convention on Mercury took place on September 5 and 6,2023, in Bangkok, Thailand. Its primary purpose was to prepare for the upcoming COP-5 meeting, scheduled for October 30 to November 3, 2023, in Geneva, Switzerland. During this preparatory meeting, the provisional agenda was discussed and developed in collaboration with COP-5 Bureau members representing the Asia and Pacific region.

ESDO's Executive Director, Siddika Sultana and Research and Campaign Associate, Shanon Iffat Alam attended the meeting on behalf of ESDO, World Alliance for Mercury Free Dentistry and Zero Mercury Working Group (ZMWG).



Regional Meeting of Fifth Meeting of the International Conference on Chemicals Management (ICCM5)

The Bonn World Conference Center hosted the ICCM5 meeting from September 25 to 29, 2023. The Intersessional Process for Consideration of the Strategic Approach to International Chemicals Management (SAICM) and the Sound Management of Chemicals and Waste Beyond 2020 (IP4.3), which took place from September 23–24, 2023, before ICCM5.

Dr. Shahriar Hossain, the secretary general of ESDO, and Siddika Sultana, the executive director of ESDO, took part in IP4.3 on ESDO's behalf. At this conference, Ms. Siddika Sultana intervened in the Strategic Objectives and Targets section on the timeline of Sound Management of Chemicals.


